ORDER OF DISMISSAL

The above-entitled matter came before the undersigned as a result of an Order to Show Cause Why Application Approval Should not be Rescinded and Application Should Not be Denied, Notice of Hearing, and Appointment of Hearing Officer dated February 2, 2021 and issued to 1011 Associates, LLC d/b/a C-3 Consultants, LLC (“Respondent”) by the Department of Business Regulation (“Department”) in relation to the Respondent’s application for a medical marijuana cultivator license. A prehearing conference was held on February 16, 2021 at which time the Respondent did not appear. On February 19, 2021, the Respondent stated in e-mail correspondence to the Department and the Hearing Officer that he was no longer pursuing the medical marijuana cultivator license, Application No. MMP CV 0060 (“the Application”). 
