Any product that differs from the product list below must be submitted to OCR for review and designation before it is eligible for sale at a compassion center. Pursuant to § 1.7(G) of 230-RICR-80-05-1, product designation(s) may be withdrawn, denied or revoked by DBR if the product fails to satisfy any provision of the Act or the DBR Regulations or if the product deviates or is altered from its previously approved form.

**Adult-Use and Medical Products**

**The below list of products are available for sale to an adult-use customer or to a patient, caregiver, or authorized purchaser.**

**Bud/Flower**

- Including Pre-Rolls with flower only
- Infused Pre-Rolls with designated concentrate(s) added to it.

**Concentrates**

- 100% marijuana with no added ingredients
- That include added hemp-derived terpenes
- That include hemp-derived non-synthetic/non-psychoactive cannabinoids
- Tinctures which may contain up to 500mgs of THC as reported by licensed testing facility per adult-use packaged product.

**Concentrates Intended for Aerosolization**

- No flavor or coloring has been added except those derived solely from cannabis and have been procured in accordance with applicable Rhode Island laws.
- No vitamin E acetate.
- An ingredient list for each unique product has been submitted to OCR.

**Marijuana Infused Products**

All below products must be tested by a licensed testing facility in final form and found to contain equal to or less than 10 mgs of THC per serving and 100 mgs of THC per package (a 10% variance is allowable).

- Baked Goods
- Gummy/Fruit Chews
- Chocolate/Caramels
- Lozenges
- Carbonated Beverages
- Fruit Drinks
- Coffee/Tea
- Culinary Additives
- Frozen Desserts

- Capsules only for oral consumption
- Topicals including Transdermal Topicals
- Metered Dose Inhalers
- RSO

All products must be in the allowable forms as listed below:

- Shape: Purely geometric shapes only (no stars or hearts)
- Suggested colors: neutral or muted colors/ no neon or bright colors
- Cannot appeal to minors
- Cannot be on a stick
- Must be shelf stable

### **Medical Only Products**

**Marijuana Infused Products as shown below and designated as “ingestible” may contain THC amounts greater than 10mgs per serving and are available for sale ONLY to a medical patient, caregiver or authorized purchaser.**

- Capsules only for oral consumption
- Topicals including Transdermal Topicals
- Metered Dose Inhalers
- RSO
